that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament.

The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Mary, Strood, being :---

"All those contiguous portions of the parish or parochial chapelry of Strood, and of the parish of Frindsbury, both in the county of Kent, and in the diocese of Rochester, which said portions of such cures are bounded on the south-east by the middle of the River Medway, that is, by the parish of Saint Nicholas, Rochester, in the county and diocese aforesaid, and upon all other sides, that is to say, on the west, on the north, and on the east, by an imaginary line commencing in the centre of Rochester Bridge, upon the boundary in the middle of the said River Medway, which divides the last-named parish from the parish or parochial Chapelry of Strood aforesaid, and extending thence north-westward along the middle of the said bridge and along the middle of Highstreet, Strood (passing under the line of the North Kent Branch of the South-Eastern Railway) to the junction of the said street with North-street, and extending thence northward along the middle of the last-named street (passing under the line of the London Chatham and Dover Railway) to the junction of the same street with the Frindsbury Road, and extending thence north-eastward for a distance of two and a-half chains, or thereabouts, along the middle of the last-named road (thereby following in part the boundary which divides the said parish or parochial Chapelry of Strood from the parish of Frindsbury aforesaid) to the junction of the same road with Stonehorselane, and extending thence first north-westward and then northward for a distance of twentyeight chains, or thereabouts, along the middle of the said lane to the boundary which divides the said parish or parochial Chapelry of Strood from the parish of Frindsbury aforesaid, and extending thence first south-eastward, and then south-westward along the said boundary (thereby again following in part the middle of the Frindsbury Road aforesaid, as far as the point, where the last-named road is joined by the New Road leading to the Strood Station on the line of the North Kent Branch of the South-Eastern Railway aforesaid, and extending thence first south-eastward, and then south-westward for a distance of nineteen chains or thereabouts, along the middle of the said New Road to its junction on the northern side of the Strood Station aforesaid) with a certain footway which crosses under the line of the said lastly-named railway to the southern side of the same station, and extending thence first south-eastward and then south-westward along the middle of the said footway to its junction with the roadway, which leads from the Strood Station aforesaid to Canal Road, and extending thence south-eastward along the middle of the last-described roadway to its junction with Canal Road aforesaid, and continuing thence still south-eastward across the last-named road to and along the middle of Strood Pier, to the south-eastern end of the same pier, and continuing thence in the same direction and in a straight line to a point upon the boundary in the middle of the said River Medway, which divides the said parish of Frindsbury from the parish of Saint Nicholas, Rochester, as first mentioned."

And whereas a draft of the said scheme has in accordance with the provisions of the hereinbefore secondly-mentioned Act, been transmitted to the patrons and to the Incumbents of the ordinary of which it is intended that the district therein recommended to be constituted shall be taken.

And whereas more than one calendar month has elapsed since drafts of the said scheme were so transmitted as aforesaid.

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester.

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirteenth and fourteenth years of Her Majesty, chapter forty-one, and of the Act of the 'nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-second day of July, in the year one thousand eight hundred and sixty-nine, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirteenth and fourteenth years of your Majesty, chapter forty-one, and of the Act of the nineteenth and twentieth years of your Majesty, chapter fiftyfive, have prepared, and now humbly lay before your Majesty in Council the following scheme for setting out and constituting a district for spiritual purposes, and annexing such district to the consecrated church of Saint Gabriel, Hulme, situate within the limits of the new parish of Saint George, Hulme (some time part of the parish of Manchester), in the county of Lancaster, and in the diocese of Manchester.

"Whereas it appears to us to be expedient that a district for spiritual purposes should be set out and constituted for and annexed to the said church of Saint Gabriel, Hulme, situate within the limits of the new parish of Saint George, Hulme, as aforesaid.

"Now, therefore, with the consent of the Right Reverend James Prince, Bishop of the said diocese of Manchester, testified by his having signed and sealed this scheme, we humbly recommend and propose that all that part of the said new parish of Saint George. Hulme, which is described in the schedule hereunder written, and is delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme, be severed and disannexed from such new parish, and shall be set out and constituted for and annexed to the said
