THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Ambassador at Paris, containing the following Imperial Decree, dated the 9th July, 1869, relating to imports and exports to and from French possessions beyond the sea:—

ART. 1. Produce of all kinds and from every country can be imported by all flags into the various French possessions beyond the sea where the Act of Navigation of the 21st September, 1793, is still in force.

Produce loaded in these same possessions can be exported for any destination and by any flag.

ART. 2. The Minister of Marine and of the Colonies is charged with the execution of the present Decree, which shall be inserted in the "Bulletin des Lois."
