

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the vicarage of Pill, in the county of Somerset, and in the diocese of Bath and Wells, and to his successors, Incumbents of the same vicarage, all those annual tithe commutation rent charges, which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said tithe commutation rent charges to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said tithe commutation rent charges, as from the first day of January, in the year one thousand eight hundred and sixty-nine.

In witness whereof, we have hereunto set our common seal, this fifth day of August, in the year one thousand eight hundred and sixty-nine.
