**T**HE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1869, and of every other power enabling them in this behalf, do hereby revoke their Order, bearing date the tenth day of August, one thousand eight hundred and sixty-nine, defining the part of the Port of Harwich, in the county of Essex, within which foreign cattle might be landed for slaughter: Provided that nothing herein shall be deemed to invalidate or make unlawful anything done under the said Order before the date of this revocation, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Order.
