THE Queen has been pleased to present the Reverend John Barclay to the church and parish of Dunblane, in the presbytery of Dunblane, and county of Perth, vacant by the death of the Reverend James Ingram.

The Queen has also been pleased to present the Reverend Angus Gunn to the church and parish of Alloa, in the presbytery of Stirling, and county of Clackmannan, vacant by the death of the Reverend William Shaw.

By virtue of an Act passed in the twenty-second year of the reign of Her Most Gracious Majesty, Queen Victoria, intituled "An Act to "extend the Act of the twenty-fourth year of "King George the Third, chapter twenty-six, for "issuing writs during any recess of the House of "Commons, whether by prorogation or adjourn-"ment;" and of an Act passed in the twenty-sixth year of the reign of Her present Majesty, intituled "An Act to further limit and define the "time for proceeding to Election during the "Recess."

I do hereby give notice, that it hath been certified to me in writing, under the hands of two Members serving in this present Parliament, in the manner required by the said Act, that the Right Honourable James Moncreiff, late a Member serving in this present Parliament for the Universities of Glasgow and Aberdeen, hath accepted the office of Her Majesty's Lord Justice Clerk in Scotland, and has been gazetted thereto in the London Gazette dated the 15th day of October, 1869, and has thereby vacated his seat; and that I shall issue my warrant to the Clerk of the Crown, to make out a new writ for the electing of a Member to serve in this present Parliament for the said Universities, at the end of six days after the insertion of this notice in the London Gazette.
