ments, for the purposes of the said Bill, or any right or easement of, in, through, or over the same, and to pay compensation for the same either by a sum in gross, or by an annual rent and with power to withdraw from any notice which may have been given for purchasing the same, or any part thereof, and free from any obligation to resell the same, or any part thereof, as superfluous lands, and to hold and demise the same, and subject to the purposes aforesaid, to regulate the purposes for which all hereditaments acquired under or by virtue of the said Bill shall be used; and to apply the rents, profits, and proceeds thereof, in aid of the Borough Fund of the said borough.

X. To empower the Corporation, in the execution of the said works, to deviate from the lines and levels delineated on the plans and sections to be deposited as hereinafter mentioned, to the extent to be defined thereon, or in the said Bill, and also to cross, stop up, alter, or divert temporarily or permanently within, adjoining or near to the said parishes, chapelry, townships, and extraparochial places all turnpike and other roads, streets, highways, footpaths, streams, courses, sewers. pipes, aqueducts, and bridges, for the purposes herein mentioned or any of them, and to vary, repeal, or extinguish all existing rights and privileges connected with the said mills, waterworks, lands, buildings, and hereditaments, or with the said streams, and waters, or their tributaries, or the rivers into which they run.

XI. To enable the Corporation to levy and receive rents, rates, and tolls, for the purposes aforesaid, and to levy and receive water rates or rents for the use of water and to alter existing

rates and rents.

XII. To alter the water rents or rates of the purchased waterworks, and assimilate them to the rents and rates paid in the parts of the borough of

Bath now supplied by the Corporation.

XIII. To authorise the Corporation to supply with water at rents or sums in gross the owner or owners for the time being of any waterworks or waterwork already constructed within or partly within the borough of Bath, other than, or in addition to, the waterworks of the Corporation.

XIV. To authorise the Corporation to raise such sum or sums of money as shall be required for the purposes of the said Bill by borrowing or

otherwise.

XV. To incorporate all or some of the provisions of "The Lands Clauses Consolidation Act, 1845," "The Lands Clauses Consolidation Acts Amendment Act, 1860," "The Waterworks Clauses Act, 1847," and "The Waterworks Clauses Act, 1863."

XVI. To amend, alter, extend, or repeal an Act passed in the session of Parliament held in the 9th and 10th years of the reign of Her Majesty Queen Victoria, intituled "An Act for more effectually supplying with water the city of Bath and several parishes and places adjacent thereto," and "The City of Bath Act, 1851," and to apply the provisions of the said Acts or some of them, to the said intended waterworks, and to the other objects of the said Bil.

XVII. Plans and sections of the said proposed new works, showing the lines and levels thereof, and the Linds in or through which the same are to be made, and plans of the several mills, waterworks, lands, and buildings so to be purchased, compulsorily as aforesaid, together with a book of reference to such plans, containing the names of the owners or reputed owners, lessees or reputed lessees, and occupiers of the said lands and works; and a copy of this notice, as published in the London Gazette, will be deposited with the Clerk

of the Peace for the county of Somerset, at his office, at Wells, in the same county, and with the Clerk of the Peace for the county of Gloucester, at the city of Gloucester, in the same county, on or before the 30th day of November, 1869; and a copy of so much of the said plans, sections, and book of reference as relates to each parish, chapelry, and extra-parochial place within which the said lands and works are intended to be made or purchased will, on or before the same 30th day of November, be deposited as follows, that is to say, as respects each of the said parishes, with the parish clerk thereof, at his residence, as respects the said chapelry of St. Catherine, with the Clerk thereof, at his residence, and in the case of any extra-parochial place, with the parish clerk of some parish adjoining thereto, at his residence.
