THE Queen has been pleased to direct Letters Patent to be passed under the Great Seal granting the dignity of a Baronet of the United Kingdom of Great Britain and Ireland unto James Clarke Lawrence, of Westbourne-terrace, in the county of Middlesex, Esq., one of the Aldermen, and late Lord Mayor, of the City of London, and the heirs male of his body lawfully begotten.
