By the Lords of Her Majesty's Most Honourable Privy Council.

THE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1869, and of every other power enabling them in this behalf, do hereby revoke their Order, bearing date the tenth day of August, one thousand eight hundred and sixty-nine, defining the part of the Port of Hartlepool, in the county of Durham, within which foreign cattle might be landed for slaughter: Provided that nothing herein shall be deemed to invalidate or make unlawful anything done under the said Order before the date of this revocation, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Order.

THE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1869, and of every other power enabling them in this behalf, do hereby define the parts of the Port of Hartlepool, in the county of Durham, within which foreign cattle may be landed for slaughter, as follows:—

All that space at the West Hartlepool Docks, in the county of Durham, within the following limits, that is to say:—at a point commencing at the north-east corner of No. 2 warehouse on the south side of the Ward Jackson Dock, at West Hartlepool, thence following the eastern wall of the said warehouse to the south-eastern corner thereof, thence by a straight line to the northeastern corner of the Swainson Dock, thence skirting the northern boundary wall of the said last-mentioned dock to the entrance thereof from

the Ward Jackson Dock, thence in a northeasterly direction to the southern boundary wall of the Ward Jackson Dock, and thence in an easterly direction along the boundary wall of the said dock to the north-east corner of No. 2 warehouse aforesaid (which space is hereinafter referred to as the landing-place No. (1)):

Also all that space at the West Hartlepool Docks, in the county of Durham, within the following limits, that is to say:—at a point commencing at the south-west corner of the entrance of the Swainson Dock from the Ward Jackson Dock, thence skirting the northern boundary-wall of the said Swainson Dock to the south-western corner of the shoddy warehouse; thence running in a straight line, along the western side of the said shoddy warehouse, to the southern side of the graving dock entered from the Ward Jackson Dock, thence in a straight line to the north-eastern corner of the slaughter-house abutting upon the Ward Jackson Dock, thence along the north side of the said slaughter-house to the boundary wall of the Ward Jackson Dock, thence in a southerly direction along the boundary wall of the said dock to the south-west corner thereof, thence continuing along the boundary wall of the said dock to the said entrance of the Swainson Dock, and thence continuing along the boundary wall of the said entrance of the Swainson Dock to the south-west corner thereof aforesaid (which space is hereinafter referred to as the landing-place No. (2)):

Both which spaces are coloured pink on the plan of the Port of Hartlepool, deposited at the Privy Council Office, a copy of which is deposited at the office of the Clerk of the Peace for the county of Durham.

And do hereby prescribe as follows:-

- 1. Regulation six of the fourth schedule to The Contagious Diseases (Animals) Act, 1869, shall not apply to cattle landed within the landing-places aforesaid
- 2. Foreign cattle may be removed out of the landing-place No. (1) across the bridge which crosses the entrance to the Swainson Dock, from the Ward Jackson Dock, to the landing-place No. (2), either for the purpose of being there slaughtered, or for the purpose of being re-shipped as hereinafter mentioned, and for no other purposes.
- 3. Foreign cattle landed within the said landing-places may, under such regulations as the Commissioners of Her Majesty's Customs from
