

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Witcham, in the county of Cambridge, and in the diocese of Ely, and to his successors, Incumbents of the same vicarage, all those tithe commutation rent charges which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said tithe commutation rent charges to the use of the said Incumbent, and his successors for ever: Provided always, that the said tithe commutation rent charges shall be and be held to be in lieu of and in full substitution for an annual stipend of forty-two pounds, heretofore payable by us, or by the Dean and Chapter of the Cathedral Church of the Holy and Undivided Trinity in Ely, to the Incumbent of the said vicarage in respect of certain property situate and arising within the parish of Witcham aforesaid; And provided also, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said tithe commutation rent charges, as from the twenty-fifth day of March, in the year one thousand eight hundred and sixty-nine.

In witness whereof, we have hereunto set our common seal, this twenty-seventh day of January, in the year one thousand eight hundred and seventy.
