The Government of India, after communication with various Agricultural and Horticultural Societies in India, and with persons interested in the subject, has arrived at the conclusion that the only real obstacle to the development of an extensive trade in the filre of Rheea, or China-grass, is the want of suitable machinery for separating the fibre and bark from the stem, and the fibre from the bark, the cost of effecting such separation by manual labour being great.

2. The demand for the fibre is now large, and no doubt might be extended with reduced prices, and there is a practically unlimited extent of country in India where the plant could be grown.
