

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Mathon, in the county of Worcester, and in the diocese of Worcester, and to his successors, Incumbents of the same vicarage, all those annual tithe commutation rent charges which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said tithe commutation rent charges to the use of the said Incumbent, and his successors for ever: Provided always, that the said tithe commutation rent charges shall be and be held to be in lieu of and in substitution for the annual stipend of eighty pounds, heretofore payable by us to the Incumbent of the said vicarage in respect of certain property situate and arising within the parish of Mathon aforesaid, formerly belonging to the Dean and Chapter of the Collegiate Church of Saint Peter, Westminster; And provided also, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said tithe commutation rent charges, as from the twenty-ninth day of September, in the year one thousand eight hundred and sixty-six.
