Fixed Light on Jourimain Island.

THE Canadian Government has given notice, that from the 15th day of May, 1870, a light will be exhibited from a lighthouse recently erected on Jourimain Island, Northumberland

The light will be a fixed white light, elevated 72 feet above high water, and in clear weather should be seen from a distance of 14 miles.

The lighthouse is 40 feet high, octagonal shaped, and painted white; it stands 66 feet from the extremity of the cliff, and its position, as given, is in lat. 46° 10' N., long. 63° 50' W.
