WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Byker, in the county of Northumberland, and in the diocese of Durham, and to his successors, Incumbents of the same vicarage, all our estate and interest in the piece or parcel of land and hereditaments, with the appurtenances thereunto belonging, particularly described in the schedule hereunto annexed, and now vested in us, subject to certain reservations and conditions under and by virtue of a certain deed of conveyance, bearing date the first day of June, in the year one thousand eight hundred and sixty-nine, and made between Sir Walter Charles James, Baronet, the Reverend Henry Byne Carr, Clerk, and John Clayton, Esquire, of the first part, Dame Sarah Caroline James (wife of the said Sir Walter Charles James) of the second part, John George Smyth, Esquire, of the third part, and us, the said Ecclesiastical Commissioners for England, of the fourth part, which said deed of conveyance is intended to be deposited in the registry of the said diocese of Durham, immediately after the publication of these presents in the London Gazette.

All that piece or parcel of land, comprising two roods or thereabouts, situate in the new parish of Byker, in the borough and county of Newcastle-upon-Tyne, bounded on the west by a lane called Byker-lane, and on the north by lands belonging to Sir Wilfrid Lawson, Baronet, on the east by lands belonging to Sir Matthew White Ridley, Baronet, and on the south by land belonging to Lady James, which said piece or parcel of land is delineated and colored green on the plan hereunto annexed.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant to the Incumbent of the vicarage of Whitchurch, in the county of Southampton, and in the diocese of Winchester, and to his successors, Incumbents of the same vicarage, one yearly sum or stipend of one hundred and five pounds, such yearly sum or stipend to be payable out of the common fund under our control, and

to be calculated as from the eighth day of April, in the year one thousand eight hundred and seventy, and to be receivable in equal half-yearly portions on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

NOTICE is hereby given, that the Conservators of the River Thames, in exercise of the powers vested in them by the Thames Conservancy Acts, 1857 and 1864, propose to make the following Bye-Laws:—

1. When the tide is running, and two steam vessels approaching each other are about to round a point, the vessel proceeding against the tide shall ease, or if necessary, stop, until the other vessel shall have passed clear of her. At slack water, steam vessels under the same circumstances shall be considered as meeting ships, and navigated as required by the 13th Article of the Steering and Sailing Rules for preventing Collisions at Sea.

2. Any person committing any breach of, or in any way infringing this Bye-Law, shall be liable to a penalty of, and shall forfeit a sum not exceeding £5, which said penalty shall be recovered, enforced, and applied according to provisions of the said Thames Conservancy Acts.

All persons desiring to make objections to or representations respecting the proposed Bye-Law, must make such objections or representations in writing or otherwise, on or before the 24th day of June next; and a Special Meeting of the said Conservators will be held at their Office, No. 41, Trinity-square, Tower-hill, at eleven o'clock in the forenoon, on Monday, the 13th day of June next, to afford persons an opportunity of personally making to them any objection or representation respecting the proposed Bye-Laws.
