

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, do hereby grant to the Incumbent of the vicarage of Preston Candover with the chapelry of Nutley annexed, in the county of Southampton, and in the diocese of Winchester, and to his successors Incumbents of the same vicarage, one yearly sum or stipend of thirty-two pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and sixty-nine, and to be receivable in equal half-yearly portions on the first day of May and on the first day of November in each and every year: And we do also hereby grant and appropriate out of our said common fund to the said vicarage of Preston Candover with the chapelry of Nutley annexed, one capital sum of six hundred pounds sterling, to be applicable towards defraying the cost of making certain additions and improvements to and in the parsonage or house of residence of the said vicarage, according to plans and a specification to be approved by us, such capital sum or the balance thereof unapplied to such purpose to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said vicarage: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the said yearly sum or stipend of thirty-two pounds, or any part thereof, shall be annexed by us to the said vicarage in substitution for such yearly sum or stipend, or for such part

thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the vicarage of Shotwick, in the county of Chester, and in the diocese of Chester, and to his successors, Incumbents of the same vicarage, all that annual sum or pension of sixteen shillings, heretofore payable in respect of the said vicarage, and formerly receivable by the Dean and Chapter of the cathedral church of Chester, and recently by us the said Commissioners, to have and to hold the said annual sum or pension to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the said annual sum or pension, as from the first day of May, in the year one thousand eight hundred and sixty-eight.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the benefice of Saint Stephen, Low Elswick, in the county of Northumberland, and in the diocese of Durham, and to his successors Incumbents of the same benefice, all that tithe commutation rent charge which is particularly described in the schedule hereunto annexed, and is now vested in us, to have and to hold the said tithe commutation rent charge to the use of the said Incumbent and his successors for ever: Provided always, that the said tithe commutation rent charge shall be, and be held to be, in lieu of, and in substitution for, a portion amounting to one pound and fourteen shillings of the annual grant of three hundred pounds heretofore payable by us, the said Commissioners, to the Incumbent of the said benefice, under the authority of an Instrument sealed by us and published in the London Gazette of the twentieth day of November, in the year one thousand eight hundred and sixty-eight; And provided also, that the Incumbent for the time being of the same benefice shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said tithe commutation rent charge, as from the first day of May, in the year one thousand eight hundred and seventy.
