## The New Forest.

## Disafforestation.

**N**OTICE is hereby given, that application is intended to be made to Parliament in the Session of 1871, for an Act for effecting the following, or some of the following objects, that is to say, First, the repeal, altering, or amending the following Acts of Parliament relating in whole or in part to the New Forest, in the county of Southampton, that is to say;—The Public General Acts, 9th and 10th William the 3rd, chapter 36; the 39th and 40th George the 3rd, chapter 86; the 41st George the 3rd, chapter 108; the 48th George the 3rd, chapter 72; the 50th George the 3rd, chapter 116; the 51st George the 3rd, chapter 94; the 59th George the 3rd, chapter 86; the 10th George the 4th, chapter 50; the 12th and 13th Victoria, chapter 81; the 14th and 15th Victoria, chapter 76; the 16th Victoria, chapter 19; the 17th and 18th Victoria, chapter 49; the 29th and 30th Victoria, chapters 62 and 66, and the Local and personal Act of Parliament, 8th and 9th Victoria, chapter 93, being the Southampton and Dorchester Railway Act, 1845. Second, the abolishing forestal offices in or over the same forest, and making compensation to the holders of such offices. The definition of the boundaries of the said forest or some part or parts thereof. The division of the said forest or some part or parts thereof into parishes or Ecclesiastical districts, and the addition of parts of the same forest to existing parishes or ecclesiastical districts; the alteration of the boundaries of existing parishes and ecclesiastical districts, and the making of allotments for or in connection with churches, schools, and other purposes. The ascertain-

ment of the value of the rights of Her Majesty in the said forest or some part or parts thereof, and of all rights of common of pasture rights of common of turbary rights of common of mast and other rights of common, and of all rights of having or getting heath or furze, and fuel, and fuel wood, rights of having digging or getting marl, and of all other rights belonging to any persons or bodies corporate in, upon, or over the said forest or any part or parts thereof. The making of allotments of part or parts of the said forest, or of other compensation in satisfaction of the aforesaid rights or some of them, and the making provision for the vesting, management, regulation, use, and enjoyment of such allotments, or some part or parts thereof. The ascertainment, setting out, making and future maintenance and repair, and the stopping up, diversion, abolition, and discontinuance of all or any roads and ways or rights of way over the said forest. The imposition of penalties, and provisions for recovery thereof. The confirmation and carrying out of the register of decisions or award of the Commissioners appointed to enquire into the rights of common in the New Forest under the said Acts 14th and 15th Victoria, chapter 76; the 16th Victoria, chapter 19; and the 17th and 18th Victoria, chapter 49. The authorizing the application to the purposes of the Act of the balance of the purchase money received by the Crown from the Southampton and Dorchester Railway Company for land in the said forest taken by them. The authorizing the Commission or Commissions to be appointed under the Act, to sell a part or parts of the said forest, and to apply the purchase money to the purposes of the said Act, and the authorizing of compensation to all persons whose offices shall be abolished by the said Act, and to fuel assignment holders. Third, the disafforestation of the said forest or some part
