Fixed Light on Great Bird Rock.

THE Government of the Dominion of Canada has given notice, that a light is now exhibited, during the season of navigation, from a lighthouse recently erected on the Great Bird Rock, the north-easternmost of the Magdalen Islands.

The light is a fixed white light, elevated 140 feet above the level of the sea, and in clear weather should be seen from a distance of 21 miles.

The illuminating apparatus is dioptric or by lenses, of the second order.

The tower, 50 feet high, is a wooden frame building painted white, and is situated on the eastern end of the rock. Position, lat. 47°50'40" N., long, 61°8'20" West.

66 yards from the lighthouse.
