THE Queen has been pleased to appoint George Shine, Esq., to be a Member of the Legislative Council of the Island of Trinidad.

By virtue of an Act passed in the twenty-fourth year of the reign of His Majesty King George the Third, intituled "An Act to repeal so much of two Acts made in the tenth and fifteenth years of the reign of His present Majesty as authorizes the Speaker of the House of Commons to issue his Warrant to the Clerk of the Crown for making out writs for the election of Members to serve in Parliament, in the manner therein mentioned, and for substituting other provisions for the like purposes;" and of an Act passed in the twenty-sixth year of the reign of Her present Majesty, intituled "An Act to further limit and define the time for proceeding to Election during the Recess:"

I do hereby give notice, that the death of Matthew Elias Corbally, Esq., late a Member serving in this present Parliament for the county of Meath, hath been certified to me in writing, under the hands of two Members serving in this present Parliament; and that I shall issue my Warrant to the Clerk of the Crown to make out a new writ for the electing of a Member to serve in this present Parliament for the said county at the end of six days after the insertion of this notice in the London Gazette.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, two Despatches from Her Majesty's Minister at Madrid, reporting that, by virtue of an Order published by the Spanish Minister of the Colonies, the following alterations have been made in the Custom-houses of the Island of Puerto Rico.

A Custom-house has been established for purposes of general commerce at the port of Guanica. The Custom-house of Naguabo has been removed to the place called Punta de Santiago, in the port of Humocao. And that Custom-house habilitation for general commerce has been given to the port of Fajardo.
