THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, through the Secretary of State for Foreign Affairs, from Her Majesty's Ambassador at Versailles, an extract from the "Journal Officiel" of the 17th instant, containing a Decree of the French Government relating to public contracts for war material, &c., and of which the following is a transla-

Art. 1. A Commission, composed of sixty members of the National Assembly, nominated by the Bureaus at the rate of four members per Bureau, is charged with examining all the contracts passed by the public departments on account of the war, payable wholly or in part by the State, and with checking the regularity of their negotiation and execution.

Art. 2. Copies of all contracts concluded with persons other than those agents authorised for this purpose by laws, decrees, ordinances, or regulations, shall be, on the responsibility of the parties interested, and under pain of forfeiture, addressed within two months from the promulgation of the present law to the proper minister, who will transmit them to the Commission with his observations.

Art. 3. All documents and particulars of a nature to assist the Commission will be immediately placed at its disposition by the competent ministers.

All powers are conferred on the Commission for the purpose of summoning and interrogating persons able to give information and of causing them to communicate any thing likely to assist it in its labours.

Art. 4. A report shall be addressed by the Commission to the National Assembly.
