THE Spanish Government has given notice, that from the 5th March, 1871, a light would be exhibited from a lighthouse recently erected on Cape Cruz, south side of Cuba.

Îhe light is a fixed and flashing white light, showing a flash every three minutes, elevated 114 feet above the sea, and in clear weather should be seen from a distance of 16 miles.
