

WE, the Ecclesiastical Commissioners for England, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, and in consideration of a benefaction consisting of a clear annual rent charge of fifty pounds, upon the tithe commutation rent charges arising within the township of Pemberton, within the original limits of the parish of All Saints, Wigan, in the county of Lancaster, and in the diocese of Chester, and forming part of the endowments of the rectory of the same parish, which said annual rent charge has been permanently secured to the lately constituted district of Saint Andrew, Wigan, in the same county and diocese, and in consideration of a further benefaction consisting of one thousand and five hundred pounds sterling, which has been paid to us in favour of the said district, and in respect of which we have agreed to pay to the Minister thereof, and to his successors, a yearly sum of fifty pounds, do hereby grant to the Minister of the said district of Saint Andrew, Wigan, and to his successors, to meet such benefactions, one other yearly sum or stipend of fifty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the yearly sum or stipend so payable out of our common fund, as lastly herein mentioned, or any part thereof, shall be annexed by us to the said district, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, and in consideration of a benefaction consisting of one hundred pounds per annum, which, under the authority of an Order of Her Majesty in Council, bearing date the twenty-fourth day of March, one thousand eight hundred and seventy-one, and published in the London Gazette of the twenty-eighth day of the same month, has been permanently secured to the consolidated chapelry of Saint Mary, Wolverton, in the county of Buckingham, and in the diocese of Oxford, out of the endowments of the vicarage of Wolverton, in the same county and diocese, and in consideration of a further benefaction of seven hundred and fifty pounds sterling, which has been paid to us in favour of the said consolidated chapelry, and in respect of which we have agreed to pay to the Incumbent thereof, and to his successors, a yearly sum of twenty-five pounds, do hereby grant to the Incumbent of the said consolidated chapelry of Saint Mary, Wolverton, and to his successors, to meet such benefactions, one yearly sum or stipend of forty-eight pounds six shillings and eight pence, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Ga-

zette, and to be receivable in equal half-yearly portions on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the yearly sum or stipend so payable out of our common fund, as lastly herein mentioned, or any part thereof, shall be annexed by us to the said consolidated chapelry, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, and in consideration of a benefaction of one thousand pounds sterling, which has been paid to us in favour of the vicarage of the Holy Trinity, Weymouth, in the county of Dorset, and in the diocese of Salisbury, do hereby grant to the Incumbent of the said vicarage of the Holy Trinity, Weymouth, and to his successors, Incumbents thereof, one yearly sum or stipend of sixteen pounds thirteen shillings and four pence, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: And we do also in further consideration of the aforesaid benefaction, hereby grant and appropriate out of our said common fund, to the said vicarage of the Holy Trinity, Weymouth, one capital sum of five hundred pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said vicarage, according to plans and a specification to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said vicarage of the Holy Trinity, Weymouth: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the said yearly sum or stipend of sixteen pounds thirteen shillings and four pence, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
