

tinue to use the surname of West, and take, use, and bear that of Sackville only; and that he may bear the arms of Sackville; and that the said surname and arms of Sackville may in like manner be taken, borne, and used by his issue; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms; otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be registered in Her Majesty's said College of Arms.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, copy of a Proclamation of the President of the United States of the 25th February last, ordering the discontinuance of discriminating duties hitherto levied in the ports of that country upon merchandise imported in Portuguese vessels from countries other than those of which such merchandise is the growth, produce, or manufacture, so long as the reciprocal exemption of merchandise belonging to citizens of the United States from such discriminating duties shall be granted in the ports of Portugal.
