- 8. General Intelligence Exercise (as in the Attachés' Second Examination).

Optional.

- 9: German (translating into, writing, speaking, and reading MS.).
- 10. Geography and History of Europe, from 1783 to 1847, inclusive.
- 11. Constitutional History of England (Hallam and May).
- · 12. Geometry (Euclid I-IV).
- 13. Ancient Greek.
- 14: Italian or Spanish:

The limit of age for Candidates is between 18 years complete and 24 years complete, except in the case of those who may not reside with relatives, or have an established and respectable home in the metropolis, or in its immediate neighbourhood; in this latter case, the minimum of age is 20 years complete.
