"THE FAIRS ACT, 1871."**CUCKFIELD FAIR, SUSSEX.**

IN pursuance of the above-mentioned Act, I, the Right Honourable Henry Austin Bruce, one of Her Majesty's Principal Secretaries of State, hereby notify as follows:

1. By Memorial, dated the 10th day of July, 1871, a representation has been duly made to me by the Magistrates of the Petty Sessional District of Cuckfield, in the county of Sussex, that a Fair has been annually held in the parish of Cuckfield, in the said district and county, on the 16th and 17th days of September, and that it would be for the convenience and advantage of the public that such fair should be abolished.
