The Queen has been pleased to grant unto Nicholas Hermann Bernard, of Bickley, in the parish of Bromley, in the county of Kent, Esquire, Master of Arts, sometime of Queen's College, in the University of Cambridge, and unto Anne, his wife, eldest daughter and coheir of William George Ashby (formerly William George Latham), Lieutenant in the Royal Navy, deceased, Her Royal licence and authority that they may, in compliance with a proviso contained in the last will and testa-

ment of Mary Elizabeth Ashby, late of Quenby Hall, in the county of Leicester, Widow (the great grandmother of the said Anne Bernard), hencetorth take and use the surname of Ashby only, and that he the said Nicholas Hermann Bernard may bear the arms of Ashby only, and that such surname and arms may be taken, borne, and used by the issue of their marriage; such arms being first duly exemplified according to the laws of arms and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be registered in Her Majesty's said College of Arms.

Board of Trade, Whitehall, July 27, 1871.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received from the Consul of the United States of Colombia at Liverpool, a copy of a Decree of his Government, dated the 3rd April last, relating to the inspection for statistical and other purposes, of goods imported and exported at the free ports of Colombia.

The tollowing is a translation of the Articles of the Decree :-

Art. 1. The journals and invoices specified in the 2nd section of chapter 2 of the Code of Customs shall be required in all the free ports.

Art. 2. The default in presenting the said documents or their deficiency or inaccuracy shall be punished in accordance with the respective provisions of the Code.

Art. 3. The examination of cargoes in the free ports shall be performed by the chiefs of the preventive service in those ports, and as the packages are unloaded, and it shall be limited to noting the marks, numbers, and form of each package, and the total number of them.

Art. 4. When the ship goes from port to port, to disembark only a part or its cargo in the free port, the proceedings shall be as directed in Art. 27 of the Code.

Art. 5. The Consular Agents shall distribute the copies of the journals and invoices of the merchandize directed to the free ports, and shall act in every thing respecting them as is done with those of goods intended for the qualified ports.
