THE Civil Service Commissioners hereby give notice, that at the Competitive Examination for Clerkships, &c., in various Departments, appointed to be held on the 22nd August, 1871, notice of which examination was given in the London Gazette of the 14th July, 1871, twenty candidates will be selected.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant to the Incumbent of the vicarage of Titchfield, in the county of Southampton, and in the diocese of Winchester, and to his successors, Incumbents of the same vicarage, one yearly sum or stipend of seventy-one pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and sixty-nine, and to be receivable in equal half-yearly portions; on the

first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

In witness whereof, we have hereunto set our common seal, this tenth day of August, in the year one thousand eight hundred and seventy-one.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of five hundred and ten pounds sterling, which has been paid to us in favour of the vicarage of Saint John the Baptist, Wilberfoss, in the county of York, and in the diocese of York, and in respect of which we have agreed to pay to the Incumbent of the same vicarage, and to his successors, a yearly sum of seventeen pounds, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said vicarage of Saint John the Baptist, Wilberfoss, and to his successors, to meet such benefaction, one other yearly sum or stipend of seventeen pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient to produce the yearly sum or stipend so payable out of our common fund, as lastly herein mentioned, or any part thereof, shall be annexed by us to the said vicarage in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Saul, in the county of Gloucester, and in the diocese of Gloucester and Bristol, and to his successors, Incumbents of the same vicarage, all that tithe commutation rent-charge which is particularly described in the schedule hereunto annexed, and is now vested in us, to have and to hold the said tithe commutation rent-charge to the use of the said Incumbent and his successors for ever: Provided always, that the said tithe commutation rent-charge shall be, and be held to be, charged and chargeable at all times for ever hereafter with the liability for the payment to the Incumbent for the time being of the benefice of Framilode, in the said county of Gloucester and diocese of Gloucester and Bristol, of an annual
