THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1869, (in this Order referred to as the Act of 1869,) and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

 This Order shall take effect from and immediately after the twenty-ninth day of September, one thousand eight hundred and seventy-one; and words in this Order have the same meaning as in the Act of 1869.

2. Notwithstanding anything in the Order of Council bearing date the twenty-fourth day of June, one thousand eight hundred and seventyone, (specifying the ports in Great Britain at which foreign animals may be landed,) foreign animals may be landed at the port of Newhaven.

3. All the regulations applicable to the landing of foreign animals at the ports comprised in the Schedule to the said Order shall apply to foreign animals landed at the port of Newhaven.

THE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1869, and of every other power enabling them in this behalf, do hereby define the part of the Port of Newcastle-upon-Tyne, in the borough and county of that name, within which foreign cattle may be landed for slaughter, as follows:-

All that space situate in Sandgate, within the borough of Newcastle-upon-Tyne, lying between the River Tyne and a line drawn due north from a point on the north bank of the River Tyne, at the eastern end of the Rotterdam Wharf, across the north shore to the wall forming the southern boundary of the property of the North-Eastern Railway Company, thence westward along the said boundary wall to the road called Wide Open, thence northward for a distance of twenty yards along the wall forming the western boundary of the said Railway Company's property, thence eastward for a distance of twenty-five yards along the northern boundary of the property of the said Railway Company, thence in a straight line in a northerly direction, passing the west end of the row of houses near the railway terminus, to the southern side of St. Ann's-street, thence westward along the southern side of St. Ann'sstreet to the western side of the said road called Wide Open, thence southward along the western side of Wide Open for a distance of fifteen yards, thence in a westerly direction for a distance of twenty-four yards along a boundary on the south side of the sheep-pens belonging to the Corporation of Newcastle-upon-Tyne, thence in a northerly direction along a wall on the western side of the said sheep-pens to the south side of St. Ann's-street, thence along the southern side of St. Ann's-street to the passage called Bowey's Chare, thence southward along the eastern side of Bowey's Chare to the south side of the lane called Sandgate Middle-lane, thence westward along the southern side of Sandgate Middle-lane to the north-west corner of the Public Slaughter-houses, thence southward in a straight line along the western end of the Public Slaughter-houses to the public road called the North Shore, and by a continuation of the same straight line due south to the River Tyne, all which space is edged brown on the plan of part of the town of Newcastle-upon-Tyne, deposited at the Privy Council Office, a copy of which is deposited at the office of the Town Clerk of the borough of Newcastle-upon-Tyne.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a Despatch from Her Majesty's Consul at Patras, reporting that all vessels arriving in Greek ports will be required to furnish themselves with bills of health from the Greek Consul at the port from which they departed; and if there be no Greek Consul at that port, then from a Consul of some other nation. If the vessel be furnished with a foul bill of health, she must proceed to one of the undermentioned ports to perform quarantine; viz.:—

Corfu, Delos, Sciathos,

Agio Yorghi, in the Bay of Salamis; if she have no bill of health from the Greek Consul, nor from any other Consul, she will be subjected to a quarantine of observation of from five to eleven days, according to the depositions of the crew and passengers.
