THE Queen has been pleased to give and grant unto Thomas Pavier, of Wall, in the county of Stafford, Gentleman, son of Thomas Pavier, late of Edjall, in the parish of St. Michael, Lichfield, Gentleman, by Mary, his wife, sister of Edward Jackson, late of Wall, in the aforesaid county of Stafford, Gentleman, all deceased, Her Royal licence and authority that he and his issue may, in compliance with an injunction contained in the last will and testament of the said Edward Jackson, henceforth take and use the surname of Jackson, instead of that of Pavier :

And also to command that the said Royal concession and declaration be recorded in Her Majesty's College of Arms.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Decree of the Spanish Government, relating to the transit of tobacco and woven goods. It is provided that vessels measuring at least 120 metrical tons, arriving from any foreign port with cargoes of such goods, destined for the free ports of the Canaries, or for any other foreign port, may be allowed to perform quarantine at the fowl lazarets of Mahon, San Simon, or Tambo, on condition that the tobacco and woven goods are specified in the manifests required by the Customs Authorities, and that the captains perform no commercial operation in any of the ports of the Peninsula and Balearic Isles. Vessels measuring less than 120 metrical tons are admitted to the same advantages, subject to proof of necessity for performing quarantine, and to the delivery of a bond for, or the deposition of the sums of, 750 pesetas on each bale of woven goods, and 14 for each kilogramme of tobacco, repayable on the production of a certificate from a Spanish Consul of the delivery of the goods at their destination. Tobacco and woven goods carried in other vessels not included in the exceptions of Art. 127 of the Customs Ordinances or of Art. 6 of Appendix 20 thereto, are liable to the payment of the Tariff duty or to fixed penalties, unless the arrival be caused by "force majeure."
