## THE FAIRS ACT, 1871.

## SOUTHWICK FAIR.

IN pursuance of the above-mentioned Act, I, the Right Honourable Henry Austin Bruce, one of Her Majesty's Principal Secretaries of State, hereby notify as follows:

1. By Memorial, dated 2nd day of April, 1872, a representation has been duly made to me by the Churchwardens and Overseers of the parish of Southwick, in the county of Sussex, as Owners of the hereinafter mentioned Fair, that a Fair has been annually held on the 19th day of May, in the said parish in the said county, and that it would be for the convenience and advantage of the public that such Fair should be abolished.

2. On the 4th day of May, 1872, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fair.
