

## THE FAIRS ACT, 1871.

## PULHAM ST. MARY MAGDALEN FAIR, NORFOLK.

IN pursuance of the above-mentioned Act, I, the Right Honourable Henry Austin Bruce, one of Her Majesty's Principal Secretaries of State, hereby notify as follows:

1. A representation has been duly made to me by the Justices sitting in Petty Sessions for the division of Earsham, in the county of Norfolk, that a Fair has been annually held on the third Thursday and Friday in the month of May, in the village of Pulham Saint Mary Magdalen, in the parish of Pulham, in the said division of the said county, and that it would be for the convenience and advantage of the public that such Fair should be abolished.

2. On the 4th day of May, 1872, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fair.
