The Queen has been pleased to grant unto Francis Holland, of Admington House, in the county of Gloucester, and of Cheltenham, in the same county, Esquire, in the Commission of the Peace and a Deputy Lieutenant for the county of Worcester, second but eldest surviving son of Francis Holland, late of Cropthorne, in the said county of Worcester, Esquire, by Anne, his wife, eldest daughter of John Corbett, late of Quinton, in the said county of Gloucester, Esquire, and sister of Michael Corbett. late of Admington aforesaid, Esquire, all deceased, Her Royal licence and authority that he and his issue may, in compliance with a proviso contained in the last will and testament of his maternal uncle the said Michael Corbett, take and henceforth use the surname of Corbett, in addition to and after that of Holland, and that he and they may bear the arms of Corbett; such arms being first duly exemplified according to the laws of arms and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect :

And to command that the said Royal concession and declaration be registered in Her Majesty's College of Arms.
