THE FAIRS ACT, 1871.

SOUTH BENFLEET FAIRS.

IN pursuance of the above-mentioned Act, I, the Right Honourable Henry Austin Bruce, one of Her Majesty's Principal Secretaries of State, hereby notify as follows :

1. By Memorial, dated the 13th day of June, 1872, a representation has been duly made to me by the Justices sitting in Petty Sessions for the Rochford Division of the county of Essex, that Fairs has been annually held on the 24th day of August in the public street of the town of South Benfleet, and on the 24th day of June in Canvey Island, both in the parish of South Benfleet, in the said division of the said county, and that it would be for the convenience and advantage of the public that such Fairs should be abolished.

2. On the 1st day of August, 1872, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fair.
