FIDDLERS HAMLET FAIR, ESSEX.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by Thomas Coxhead Chisenhale Marsh, of Gaynes Park, in the county of Essex, Esq., as owner of the hereinafter-mentioned Fair, that a Fair has been annually held on the 20th day of July, at the Fiddlers Hamlet, in the parish of Thoydon Garnon, in the Petty Sessional Division of Epping, in the county of Essex, and that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas notice of the said representation, and of the time when I should take the same into consideration, has been duly published in pursuance of "The Fairs Act, 1871:"

And whereas, on such representation and consideration, it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished:

Now therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held on the 20th day of July, at the Fiddlers Hamlet, in the parish of Thoydon Garnon, in the Petty Sessional Division of Epping, in the county of Essex, shall be abolished as from the date of this order.
