

priety of the proposed boundaries, by Arnold Taylor, Esquire, the Inspector appointed by the Local Government Board for that purpose :

Now, therefore, we, the said Local Government Board, after consideration of the matter, do hereby, in pursuance of the powers vested in us by the Local Government Act, 1858, and the Local Government Board Act, 1871, make order :—

That from and after the date of this present Order the boundaries hereinafter set forth and described and delineated on the plan referred to in and accompanying the report of the said Inspector, bearing date the 9th day of August, 1872, shall form and constitute the boundaries of the district to be called the Newington District, for the purposes of the Local Government Act, 1858, and that the parts included in such boundaries so described and delineated shall, for the purposes of such Act, be deemed to be a place having a known and defined boundary, and may adopt the said Act accordingly :—

The boundaries hereinbefore referred to commence at the north-western extremity of the proposed district, at the north-east corner of Culvert-lane, in a detached portion of the parish of North Ferriby, and on the boundary line of the parliamentary borough of Kingston-upon-Hull, thence the said boundaries extend in a southerly direction along and include the ditch or watercourse running on the east side of Culvert-lane, thence to the south side of Anlaby-road, thence in a westerly direction along but excluding such last-named road, as far as Common East Drain ; thence in a southerly direction along and including such last-named drain and the new drain south of Common East Drain to the River Humber, and to low water mark of lowest spring tides, thence in an easterly direction along such line of low water mark to the boundary line of the town and county of Kingston-upon-Hull, thence in a northward direction along such last-named boundary line to the point where it meets the northern boundary line of the parliamentary borough of Kingston-upon-Hull, thence in a westerly direction along such last-named boundary line to the starting point at the north-east corner of Culvert-lane.

And we do hereby appoint Thomas Hardy, of Havelock-terrace, Dairy Coates, near Hull, Assistant Overseer, to be Summoning Officer, under the provisions of section 16 of the said Local Government Act, 1858, and to take such steps as may be necessary for convening a meeting to decide as to the adoption of the said Act within the said district, and to discharge all other duties which devolve on him as such Summoning Officer.

LOCAL GOVERNMENT ACT, 1858.

ORDER SETTLING THE BOUNDARIES OF A DISTRICT TO BE STYLED THE DISTRICT OF STOCKSBRIDGE, IN THE COUNTY OF YORK.

WHEREAS a Petition has been presented to the Local Government Board from ratepayers, resident within the hamlets of Bolsterstone, Midhope, and Green, in the parish of Ecclesfield, and the township of Hunshel, in the parish of Penistone, in the county of York, praying for the settlement of boundaries of a district to be styled the

district of Stocksbridge, for the purposes of the Local Government Act, 1858 :

And whereas the said petition set forth the proposed boundaries of the district, and was signed by one-tenth of the ratepayers resident within such boundaries, and inquiry has since been made as to the genuineness of the said petition and the propriety of the proposed boundaries by Robert Morgan, Esquire, the Inspector appointed by the Local Government Board for that purpose :

Now, therefore, we, the said Local Government Board, do hereby in pursuance of the powers vested in us by the Local Government Act, 1858, and the Local Government Board Act, 1871, make Order,

That from after the date of this present Order, the boundaries hereinafter set forth and described, and delineated on the plan referred to in and accompanying the report of the said Inspector, bearing date the 29th day of July, 1872, shall form and constitute the boundaries of the district to be called the "Stocksbridge District," for the purposes of the Local Government Act, 1858, and that the parts included in such boundaries so described and delineated, shall for the purposes of such Act, be deemed to be a place having a known and defined boundary, and may adopt the said Act accordingly :—

The boundaries hereinbefore referred to commence at the point marked A on the said plan, on the River Don, near Soughley Bridge, where the south fence of the Tin Mill, Rocher Plantation, joins that river ; thence the said boundaries extend westerly along the said fence, to the occupation road leading from Low Lathe to Holly Hall ; thence westerly along the footway leading to Olapark House, to the point marked B ; thence westerly along the summit of Hunshel Bank, crossing to Don Hill-lane and Don Hill, to the drinking trough at Mucky-lane ; thence, south-westerly along the east side of Mucky-lane, and excluding it to Horsley Well, at the junction of Mucky-lane with Carr Head-lane ; thence along the south side of the said Carr Head-land, and excluding it to Underbank-lane ; thence southerly along the east side of the said Underbank-lane, and excluding it to the Unshiven bridge over the Little Don River ; thence westerly along the course of the Little Don River to Knoll Brook, which forms the boundary between the hamlets of Green and Midhope ; thence southerly along the course of the said brook and the Salt Spring Beck, to the Ewdenbeck, which forms the southern boundary of the hamlets of Green and Bolsterstone ; thence easterly down the course of the said Ewdenbeck to its junction with the River Don, near Moor Hall Bridge ; thence, northerly, along the course of the said River Don, to the said point marked A.

And we do hereby appoint John Armitage, of Wharnccliffe Villa, Stocksbridge, near Sheffield, to be summoning officer under the provisions of section 16 of the Local Government Act, 1858, and to take such steps as may be necessary for convening a meeting to decide as to the adoption of the said Act within the said district, and to discharge all other duties which devolve on him as such summoning officer.
