## THE FAIRS ACT, 1871.

## THRANDESTON FAIR, SUFFOLK.

IN pursuance of the above-mentioned Act, I, the Right Honourable Henry Austin Bruce, one of Her Majesty's Principal Secretaries of State, hereby notify as follows:

1. By Memorial, dated the 14th day of August, 1872, a representation has been duly made to me by the Mayor, Aldermen, and Burgesses of the borough of Eye, in the county of Suffolk, that a Fair has been annually held on the last day of July, and the first day of August, formerly at Thrandeston, in the said county of Suffolk, and latterly within the borough of Eye aforesaid, and that it would be for the convenience and advantage of the public that such Fair should be abolished.

2. On the 26th day of September, 1872, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fair.

## PRITTLEWELL FAIR, ESSEX.

county, and that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas notice of the said representation, and of the time when I should take the same into consideration, has been duly published in pursuance of "The Fairs Act, 1871:"

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas Sir Arundell Neave, of Dagnam Park, in the county of Essex, Bart., Lord of the Manor of Earls Hall, in the parish of Prittlewell aforesaid, and Daniel Robert Scratton, of Oggwell, in the county of Devon, Esq., Lord of the Manor of Prittlewell Priory, in the parish of Prittlewell aforesaid, as lords or owners of the said Fair and the tolls thereof, have consented in writing that the said Fair should be abolished:

Now therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held on the 15th and 16th days of July, in the parish of Prittlewell, in the Petty Sessional Division of Rochford, in the county of Essex, shall be abolished as from the date of this order.
