Fixed and Flashing Light on Torbiörnskiær.

WITH reference to Notice to Mariners No. 65, dated 16th July, 1872, on the intended exhibition of a light on Torbiörnskiær, east side of the entrance of Christiania Fiord,—

In thick or foggy weather a bell will be sounded every minute with five strokes in rapid succession.

## NOTICE TO MARINERS.

(No. 79.)—United States—Maine.

Beacon Lights at Entrance of Burnt Coat Harbour.

THE United States Government has given notice, that two beacon lights have been established at the entrance of Burnt Coat Harbour. Swan Island.

The lights are fixed white dioptric lights, and bear from each other N.E. 3 N. and S.W. 3 S., 100 feet apart.

The southern light is of the fifth order, elevated 42 feet above the sea, and is exhibited from a brick tower 17 feet high.

The northern light is of the fourth order, elevated 75 feet above the sea, and is exhibited from a brick tower 32 feet high.

The approximate position is lat. 44° 8' N.,

long. 68° 27' W.

Directions.—Entering the harbour, bring the lights in line bearing N.E. 3 N., and when near the southern light steer E. by N. a quarter of a mile to the anchorage. Six fathoms water can be

Burnt Coat Harbour is a good harbour of refuge, and can afford shelter to a large number of vessels.

Virginia—Chesapeake Bay—Hampton Roads. Fixed and Flashing Light on the Thimbles.

Also, that from the 10th October, 1872, a light will be exhibited from a screw-pile lighthouse recently erected on that part of the Horse-shoe Bank known as the Thimbles, entrance to Hampton Roads.

The light will be a fixed white light, varied by red flashes every half minute, elevated 44 feet above high water, and in clear weather should be seen from a distance of 12 miles.

The illuminating apparatus is dioptric or by

lenses, of the fourth order.

The lighthouse stands in 11 feet at low water springs, and is painted white. From it Old Point Comfort Lighthouse bears W. by S. 4 S., distant 3½ miles.

In foggy weather and snow storms, a fog bell

will sound at intervals of five seconds.

Note.—Vessels going into Hampton Roads will pass to the southward of the light, between it and the black buoy on Willoughby Spit.

### Discontinuance of Willoughby Spit Light.

Also, on the same date, the light exhibited from the light-vessel off Willoughby Spit will be discontinued, and the light-vessel removed.

# NORTH CAROLINA-CROATAN SOUND. Alteration in Roanoke Marshes Light.

light to a fixed red light.

#### Louisiana-Mississippi River.

Fog Signals at Pass à L'Outre and South-west Pass.

Pass à L'Outre.—Blasts of fifteen seconds with
