Despatch from Her Majesty's Agent and Consul-General in Egypt, relative to the state of the Public Health in the Soudan and Upper Egypt; and it appears that there is every reason to hope that Cholera will shortly have totally disappeared from those districts. The prohibition on boats ascending the Nile has now been removed, and the Board of Health have resolved, provided the news from the upper country continued favourable, to remove the sanitary cordon now established at Gebet, Silsileh, and Assouan, to Korosko.
