## THE FAIRS ACT, 1871.

## BERDEN FAIR.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Justices acting in the Walden Petty Sessional Division of the county of Essex, that a Fair has been annually held on the 1st day of June, in the parish of Berden, in the said division of the said county, and that it would be for the convenience and advantage of the public that the said Fair should be abolished :

And whereas notice of the said representation, and of the time when I should take the same into consideration, has been duly published in pursuance of "The Fairs Act, 1871."
