## NOTICE OF ADOPTION OF ACT IN THE PARISH OF SAINT GEORGE, GLOUCESTERSHIRE.

WHEREAS a resolution for the adoption of  
the Local Government Act, 1858, was, on the  
9th day of January, 1873, passed by the owners  
and ratepayers of the parish of Saint George, in  
the county of Gloucester; and notice of such  
adoption has been given, in writing, to the Local  
Government Board by the persons required to  
give the same:

Now, therefore, we, the said Local Government  
Board, do hereby consent to such adoption, and
