NOTICE TO MARINERS.

(No. 28.)—MEDITERRANEAN—ITALY—IONIAN SEA.

(1.) *Fixed Light on Cape Nau or Colonne.*

THE Italian Government has given notice, that a light is now exhibited from a lighthouse recently erected on Cape Nau or Colonne, south-east coast of Italy.

The light is a *fixed* white light, elevated 133 feet above the level of the sea, and in clear weather should be seen from a distance of 20 miles.

The illuminating apparatus is dioptric or by lenses, of the first order.

The tower is octagonal shaped, coloured white, and is attached to the keeper's dwelling. Position, lat. 39° 6' N., long. 17° 13½° E.

(2.) *Harbour Light at Comisa.*

Also, that a *fixed* light, showing *red* seaward and *white* towards the harbour, is now exhibited from a lamp-post on the extremity of the mole in Comisa Harbour, west side of Lissa Island. Position, lat. 43° 2' 20" N., long. 16° 5' E.

(3.) *Fog Signal at Entrance of Trieste Harbour.*

Also, that the fog bell on the northern point of San Teresa Mole, at Trieste, has been replaced by a steam trumpet, which, in thick or foggy weather, will sound *two blasts of six seconds' duration*, followed by an interval of *fifteen seconds*.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of a certain dwellinghouse and premises, which has been permanently secured to the vicarage of the Holy Trinity, West Greenwich, in the county of Kent, and in the diocese of Rochester, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said vicarage of the Holy Trinity, West Greenwich, to meet such benefaction, one capital sum of one thousand one hundred and forty pounds sterling, to be applicable towards defraying the cost of effecting certain works and improvements in the said dwellinghouse and premises, according to plans and a specification approved by us, and of discharging certain other incidental expenses in connection with the same house and premises, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said vicarage of the Holy Trinity, West Greenwich.
