## TOPPESFIELD FAIR.

SPECIAL REGULATIONS (Supplementary to the General Regulations of 8th April, 1872), respecting Open Competitive Examinations for the situation of Supplementary Clerk in the Solicitor's Office of the Treasury.

N.B.—These Regulations are liable to alteration.

I. The limits of age for this situation are 18 and 30, and candidates must be of the prescribed age on the first day of the examination.

II. Candidates will be required to show what preliminary training or technical education they have undergone to qualify themselves for a situation of this nature. No candidate will be eligible
