- (3). The port of Santos, in the Brazils, is declared foul of yellow fever since the 24th February, and the ports of the province of St. Paulo to be suspected of that disease from the same date.
- (4). The port of Monte Video is declared infected with yellow fever since the 11th March, and the ports of the River Plate suspected of the same disease since the same date, except the port of Buenos Ayres which continues clean.

(5). The port of Maceio is declared infected with yellow fever since the 19th February, and the ports of the province of Alagoas suspected of the same disease since the same date.

(6). The ports of Sierra Leone are declared clean since the 23rd March last.
