WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the rectory of East Wittering, in the county of Sussex, and in the diocese of Chichester, and to his successors, Incumbents of the same rectory, all that annual sum or pension of two pounds, heretofore payable in respect of the rectory of East Wittering, in the county of Sussex, and formerly receivable by the Dean and Chapter of Chichester, and recently by us, the said Commissioners; and also all those annual tenths or payments, amounting to thirteen shillings and eight pence, and also all that annual sum or payment of twelve pounds, in respect of redeemed land-tax, which said annual tenths or payments and annual sum or payment of twelve pounds were heretofore payable in respect of the said rectory, and were formerly receivable by the Bishop of Chichester, and recently by us, the said Commissioners; to have and to hold the said annual pension, tenths, and annual payment in respect of redeemed land-tax, to the use of the said Incumbent and his successors for ever.
