

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, grant and convey to the Incumbent of the rectory of Bodvari, otherwise Bodfarry, partly in the county of Denbigh, and partly in the county of Flint, and in the diocese of Saint Asaph, and to his successors, Incumbents of the same rectory, all those annual tithe commutation rent-charges which are particularly described in the schedule hereunto annexed, and are now vested in us; to have and to hold the said annual tithe commutation rent-charges to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same rectory shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said annual tithe commutation rent-charges for and in respect of the period intervening between the twelfth day of November, in the year one thousand eight hundred and seventy-two, and the date of the publication of these presents in the London Gazette.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of one thousand and five hundred pounds sterling, which has been paid to us in favour of the vicarage of the Holy Trinity, Weston, in the county of Southampton, and in the diocese of Winchester, and in respect of which we have agreed to pay to the Incumbent of the same vicarage, and to his successors, a yearly sum of fifty pounds, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said vicarage of the Holy Trinity, Weston, and to his successors, to meet such benefaction, one other yearly sum or stipend of fifty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable, in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the yearly sum or stipend so

payable out of our common fund, as lastly herein mentioned, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
