' 2. "'Three years served either before or after e first of August, one thousand eight hundred and seventy-three, or partly before and partly after that date, as Captain in command of any harbour ship or First Reserve (Coast Guard) ship, or any tender to such ship, shall count as sea service, but not as sea service in a ship of war at sea. This shall not apply to any Officer who retired before the first of August, one thousand eight hundred and seventy-three.

3. "'Service subsequent to the first of August, one thousand eight hundred and seventy-three, in tenders to harbour ships and to First Reserve (Coast Guard) ships at home, and in harbour ships abroad, and their tenders, shall, in such cases as we may direct, count as service in a

ship of war at sea."

Her Majesty having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.
