WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of North Leverton with the chapelry of Apesthorne annexed, in the county of Nottingham, and in the diocese of Lincoln, and to his successors, Incumbents of the same vicarage, all those two pieces or parcels of land and hereditaments, with the appurtenances thereunto belonging, which said pieces or

parcels of land are particularly described in the schedule hereunto annexed, and are now vested in us: To have and to hold the said two pieces or parcels of land and hereditaments, with the appurtenances, to the use of the said Incumbent and his successors for ever: Provided always, that the said lands and hereditaments shall be, and be taken to be, in lieu of, and in substitution for, a portion amounting to five pounds of the annual sum or stipend of nine pounds, heretofore payable by us, the said Commissioners, to the Incumbent for the time being of the said vicarage, under the
