WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the respective Incumbents for the time being of the benefices situate within the original limits of the parish of Manchester, in the county of Lancaster, and in the diocese of Manchester, which are named in the schedule hereunto annexed, the respective sums, the amounts of which are set opposite to the names of the said benefices respectively in the second column of the same schedule, the said sums to be payable out of the common fund under our control, for and in respect of the year ending the first day of May, in the year one thousand eight hundred and seventy-four, in equal moieties, one such moiety to be receivable on the first day of November now next ensuing, and the other on the first day of May, following: Provided always, that in the cases of Saint Luke, Chorlton-on-Medlock, and Saint John, Miles Platting, and Saint Gabriel, Hulme, the payments shall be made by us to the Incumbents of the said benefices respectively only

upon condition that sums of like amount respectively, shall be or shall have been received by the respective Incumbents of the said benefices from private sources.
