In all other cases, in pursuance of the provisions of the said Act, the stamp will be impressed on the document in respect of which the fee is payable.

stamp upon a fee paper or document has not been legitimately used, certify thereon that such stamp is a fit subject for allowance, and it shall be competent to the Commissioners of Inland Revenue, upon the production of the stamp, with such certificate, to allow the amount thereof.

The Railway Commissioners or their Registrar shall, on or before the 30th day of April, in each year, make out an account of all stamps used in their office, and shall render such account to the Lords Commissioners of Her Majesty's Treasury, and the first of such accounts shall be for the period ended 31st March, 1874; and the second and subsequent accounts for each year thereafter ended 31st March.

The Commissioners of Inland Revenue may authorise distributors of stamps and other persons to sell the stamps above referred to.
