WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twentyninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Takeley, in the county of Essex, and in the diocese of Rochester, and to his successors, Incumbents of the same vicarage, all those annual tithe commutation rent-charges which are particularly described in the schedule hereunto annexed, and are now vested in us: To have and to hold the said annual tithe commutation rent-charges to the use of the said Incumbent and his successors for ever : Provided always, that the said annual tithe commutation rent-charges shall he and be taken to be in lieu of and in full substitution for the annual sum or stipend of fifty-five pounds, heretofore payable by us, the said Commissioners, or by our lessees, to the Incumbent for the time being of the said vicarage, in respect of the rectorial tithe rent-charge arising within the said parish of Takeley, and formerly belong to the Bishoprick of London : And provided also, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said annual tithe commutation rent-charges, for and in respect of the period intervening between the twenty-fifth day of November, in the year one thousand eight hundred and seventy, and the date of the publication of these presents in the London Gazette.
