## Fog Signals for the Bar and Crosby Light Vessels.

The Dock Office, Liverpool, has given notice, that from the 1st May, 1874, the following fog signals will be established at the Bar and the Crosby light-vessels.

Powerful horns, worked by steam, will distinguish these light-vessels, and in thick or foggy weather they will be sounded regularly *three times a minute*. The sound will usually be heard from a distance of 3 or 4 miles, varying more or less with the different conditions of weather.

Note.—In the event of a fog coming on so suddenly as to prevent the steam fog horns from being used immediately, the ordinary bell, as hitherto, will be sounded until the fog horn is in readiness.

#### Flashing Light on Spectacle Reef.

#### Fixed Green Light on Carnero Point.
