Alteration of portion of Line and Levels of Railway No. 3, proposed to be authorised by the Bill.

NOTICE is hereby given, that an alteration is intended to be made of the line and levels of a portion of Railway No. 3, as delineated on the plans and sections deposited in November last in respect to the application to Parliament for the above-named Bill with the Clerk of the Peace for the county of Lancaster, and with the parish clerk of the parish of Childwall, in the said county, and as described in the notice of the intended application for such Bill, published in the

London Gazette and local newspapers in the month of November last, and which alteration consists of an alteration or deviation of so much of the said Railway No. 3 as lies between the points shown on the said deposited plans as 2 miles and 5 chains, or thereabouts, and 3 miles and 7 furlongs, or thereabouts, such altered or deviated line commencing by a junction with the aforesaid Railway No. 3 at the said point shown on the said plans as 2 miles and 5 chains, or thereabouts, and terminating at the said point shown on the said plans as 3 miles and 7 furlongs, or thereabouts, such alteration or deviation being wholly situate in the parish of Childwall, in the county of Lancaster.

Plans and sections of the proposed alteration, together with a book of reference thereto, will, on or before the 16th day of May instant, be deposited for public inspection with the Clerk of the Peace for the county of Lancaster, at his office at Preston, in that county, and a copy of so much of the said plans, sections, and book of reference as relates to the parish of Childwall aforesaid, in which the proposed alteration will be situate, will be deposited with the clerk of that parish, at his residence.
